

## TERMS OF USE (Mobile App “SortiPeï”)

Version: 1.0 – (effective as of 20/05/2025)

### 1. Identification

The website available at [www.sortipei.re](http://www.sortipei.re) (the “Site”) and the mobile app are published by Mr. Julien HAEGMAN, 60 allée des Sagoutiers, 97400 Saint-Denis. The publication director is Mr. Alexandre TRENOUL.

The Site is hosted by OVH, 2 rue Kellermann, 59100 Roubaix, France.

These Terms of Use (the “Terms”) apply to all content on the Site and the App, as well as to all Services.

SortiPeï provides a listing service for events on Réunion Island, using publicly available sources.

Using the App and Services requires accepting the Terms in effect at the time of registration.

### 2. Definitions

- **App:** The mobile application “SortiPeï,” available on third-party platforms.
- **User:** Any person who visits or uses the App, including registered users.
- **Organizer:** Any individual or legal entity organizing an event.
- **Event:** Any listed public event (music, sports, culture, etc.).
- **Content:** All text, images, logos, sounds, illustrations, source code, databases, etc.
- **Services:** All services provided or facilitated by SortiPeï.

### 3. Intellectual Property

All interfaces, logos, Dodo illustrations, drawings, code, and databases are protected (French IP Code art. L.111-1).

The App and its contents are the exclusive property of SortiPeï or their respective owners.

Modifying, copying, or reproducing any content without prior written consent is prohibited.

All trademarks, logos, graphics, drawings, photos, animations, videos, and texts are the exclusive property of SortiPeï or their rightful owners.

Users must not copy, reproduce, distribute, or commercially exploit any part of the App (including code, visuals, or audio).

### 4. Liability and Warranty

SortiPeï is an informational service. It does not guarantee the occurrence or quality of listed events. It does not guarantee the accuracy or completeness of the content. SortiPeï shall not be held responsible for:

1. How events are conducted;
2. Any direct or indirect damages related to an event;

3. Errors, omissions, or update delays;
4. User or Organizer behavior.  
Users must verify the information themselves and use it at their own risk.

## 5. **Personal Data (GDPR)**

SortiPeï does not collect personal data. Each user device is identified via a unique anonymized UUID (v4).

## 6. **Prohibited Content**

Users must comply with French law, particularly regarding intellectual property, defamation, hate speech, illegal content, and public decency.

SortiPeï may promptly remove any clearly illegal or suspicious content that violates the Terms.

Unlawful content may be removed without notice.

## 7. **Advertising & External Links**

Sponsored banners are clearly labeled.

SortiPeï disclaims any responsibility for third-party sites or services accessible through the App.

## 8. **Termination**

These Terms form a contract between the User and SortiPeï, which either party may terminate at any time.

SortiPeï may delete a user account in case of a breach of the Terms, or suspend access in case of misuse.

## 9. **General Provisions**

- **Severability:** If any clause is found invalid, the rest remain effective.
- **Governing Law:** French law applies.
- **Jurisdiction:** Court of Saint-Denis, Réunion.
- **Modifications:** SortiPeï may update these Terms. Users will be notified via the App.
